



RODEO PRINCESS TRYOUTS

Thank you for expressing an interest in becoming a representative for the North Baldwin Sheriff's Search and Rescue's Second Annual Rodeo Princess for the 2010 – 2011 year. If elected, there are certain personal and financial obligations which you must assume in order to qualify and remain a representative for the NBSSAR Rodeo Princess.

THE FOLLOWING CONDITIONS MUST BE MET IN ORDER FOR A STUDENT TO TRYOUT FOR RODEO PRINCESS:

- Must be between the ages of 6 – 12 years of age (June 1 cut off date)
- Maintain an A/B average in every subject
- Students may not have disciplinary referrals or criminal records
- Mandatory meetings must be attended
- Must sell at least one \$100.00 ad (forms are attached, more can be requested)
- Should be active in the community
- Western attire will be mandated – Hat, Long Sleeve Shirt and Boots
- Students will not be allowed to tryout unless all conditions are met

TRYOUT PROCESS

- Mandatory meetings and workshops will be scheduled by the NBSSAR rodeo director or chairman.
- Tryouts before the judges will be done in one day only at scheduled times

ELIGIBILITY

- To be eligible for tryouts a student must meet all of the criteria

AFTER BEING CROWNED

The princess must:

- demonstrate exemplary conduct at all times, including in school, at programs, or during leisure and social activities.
- have a professional appearance to set a positive example for others.
- maintain a high moral character throughout her rein.
- assist in other assignments related to the rodeo as given by the NBSSAR representative
- assist in the 2011 – 2012 crowning of rodeo princess

Failure to follow these guidelines can result in immediate dismissal from the position.

ORIENTATION MEETING

All candidates must attend the scheduled orientation meeting. The meeting will be held on May 8 at the NBSSAR building at 10:00 a.m.

All candidates will be advised in writing of responsibilities and consequences prior to tryouts. Students will have an opportunity to discuss concerns and questions with the director prior to signing a contract form, which indicated understanding and willingness to comply with all applicable rules.

The completed application package will be turned in.

(A group picture will be taken for the newspaper. Western attire is encouraged.)

CRITERIA FOR JUDGING

- Application with photo
- Ad(s) sold
- Appearance
- Essay
- Letter of Recommendation
- Community involvement
- Horsemanship

LETTER OF RECOMMENDATION

This letter should be from a respectable person who has had contact with you recently; ie: teacher, pastor, priest, or employer.

ESSAY

An essay should be written, in 100 words or less, telling the judges why this position would be important to you.

JUDGES AND SCORING

Candidates will be judged by three judges.

Crowning of the princess will be during the rodeo performance on June 4. The princess will be included in the rodeo performance on June 5.

DIRECTIONS

NBSSAR Building

Turning off of Hwy 31 take the road that runs in from of Wal-Mart, known as 7th street or Airport Rd. Travel approximately 2 miles and the building will be on your left.

Arena

Coming from the South – Traveling north on Hwy. 31 turn right on Co. Rd. 57, next to A J's Gas Station, travel approximately 3 miles. Carol Hodgson Arena will be located on your left.

Coming from the North – Traveling south on Hwy 31 turn left at International Paper Company onto Dickman Rd. Travel one mile to the dead end and turn right. Travel one mile and turn left onto Pine Grove Rd. extension west. Travel two miles to the stop sign and turn left onto Pine Grove Rd. Travel ½ mile. Carol Hodgson Arena will be located on your left.
